Pursuant to an agreement with Barbara Gabriel of the Professional Staff Congress City University of New York, herein “PSC CUNY” the American Arbitration Association, hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers for Hunter College (“HC”), Graduate Center (“GC”) and the Graduate School Welfare Fund (“GSW”).

Two Thousand Two Hundred Ninety-Seven (2,297) ballots were mailed to members on Monday, April 3, 2017, as follows: 990 HC; 1,038 GC; 269 GSW.

In order to be counted, ballots needed to be received by the Administrator no later than Thursday, April 7, 2017, at 5:00 PM. The deadline for members to vote via internet or telephone was set for Friday, April 8, 2017, at 10:00 AM.

During the course of the election Fifty-Six (56) duplicate ballots were mailed out at the request of PSC CUNY members.
