A \$66,000 deficit was budgeted for the first four months of the year. The financial statement shows an actual four-month surplus of \$403,000 when expenditures are compared to income. Over four months, we spent \$381,000 less in than budgeted and received \$88,000 more income than anticipated. This resulted in a favorable bottom line of \$469,000.

- Membership Report A. Vásquez
- A. Vásquez discussed the union's membership goals, specifically on reaching all newly hired full-timers and all part-timers. She also reported on the department rep structure being developed in each chapter and sang Woody Guthrie's "Stickin' to the Union," with original PSC-based lyrics.
- Planned Chapter Actions to Support the Contract Campaign
  Representatives from John Jay, BMCC, Baruch, CSI, Lehman, LaGuardia, CCNY and City
  Tech reported on campus-based actions during March as part of the escalating contract
  campaign.

- Adjunct logging project B. Bowen reported that the adjunct project to log hours has launched, with 600 participants, to document how many hours each adjunct actually works.
- Budget campaign B. Bowen reported that there were 60 PSC members at the Higher Ed Lobby Day in Albany and discussed the State budget.

### IV. Resolutions

Full Divestment of Public Pensions from Fossil Fuels

Resolved, that NYSUT urge NYS TRS to protect public pensions and divest from all fossil fuel holdings in keeping with their fiduciary responsibility; and be it further

Resolved, that NYSUT urge Comptroller Di Napoli to divest the NYS Common Retirement Fund he oversees from fossil fuels and consider investing in renewable energy, including community owned renewable power; and be it further

Resolved, that the NYSUT and PSC urge TIAA to provide higher education members with investment alternatives, including equities, that exclude fossil fuel investments; and be it further

Resolved, that NYSUT publicize its support for divesting N.Y.S. pensions from the fossil fuel industry and its support for investing in renewable, clean energy.

MOTION: To accept the resolution on full divestment of public pensions from fossil fuels (Motion: Environmental Justice Committee)

MOTION: To add "and PSC" after "NYSUT" in the penultimate Resolved clause.

Housing and Climate Justice in NYC

THEREFORE BE IT RESOLVED, that the PSC use its resources to inform its members of the risks of permitting further development in the flood plain and how these developments will raise housing costs for the surrounding community, fostering displacement and homelessness; and

BE IT FURTHER RESOLVED, that the PSC encourage CUNY to expand its climate education programs across the campuses; and

BE IT FURTHER RESOLVED, that the Professional Staff Congress calls on the City of New York to:

 Adopt a long-range plan that is founded on solid principles of economic and social justice and that protects tenants and homeowners facing displacement;

- Allocate funds to community-based organizations in low-income waterfront communities to develop plans and projects that protect them from adverse climate events and that sustain their long-term futures;
- Support projects in these communities that generate clean energy, reduce waste, and provide green jobs.
