I. Approval of the Agenda

**Motion to accept the agenda approved.** (Motion: A. Pearlman; second: A. Sherman)

A moment of silence was held for Ciera Glenn, a student of delegate Kathleen Barker at Medgar Evers who was murdered. Delegates made individual contributions for her family that totaled \$1,000.

II. Action Item: **Executive Council Motion: To Recommend to the Delegate Assembly Approval of Initial Contract Proposals**

President Barbara Bowen introduced the bargaining agenda and thanked the members of the Committee on Contract Negotiations (the bargaining team) for their extraordinary commitment over the last six months to developing the proposed demands.

Bowen opened the floor for questions about the demands; members of the bargaining team responded.

Bowen then opened the floor to motions and proposed amendments on the main motion.

**Motion to amend the Initial Contract Proposals to integrate the four demands in the petition submitted to the bargaining team concerning part-time instructional staff and members of the higher education officer series was defeated.** (Motion: D. Medina; second: S. John)

**Motion to defer the vote on the Motion to Approve Initial Contract Proposals to the November DA was defeated.** (Motion: J. Mineka; second: S. Aranoff)

**Motion to amend demand #1 to add “to exceed inflation” and amend demand #2 to add “and a higher percentage increase shall be applied to the top of the salary scheduled” was defeated.** (Motion: R. Yarmish; second: M. Barnhart; amended: M. Barnhart; second V. Petratos)

The main motion, to approve the initial contract proposals, was approved: 86 in favor, 11 opposed.

**Motion to adjourn was approved.** (Motion: R. Cermele; second: I. DeLutro)
