#### II. President's Report and Discussion (including written) - J. Davis

#### **Increase in travel funds**

CUNY and PSC reached an agreement on disbursing the \$1.4 million in contractual travel funds that the university did not allocate to the colleges during the COVID-19 pandemic in 2020-21. The money will be disbursed to colleges over the next two academic years. In the current contract, annual travel funds doubled from \$981,618 to \$1,863,236. In the next two academic years, members of the PSC bargaining unit will have access to the usual annual amount as well as the money not previously used. This money can also be used for online conference registration costs.

#### Report back on Membership campaign

As part of the union's membership campaign, Delegates shared their experiences and strategies in having one-on-one conversations. The outreach yielded at least 156 new members since September 1 (our records await CUNY payroll information). The membership campaign will become increasingly

critical as PSC heads into the budget seasons and contract campaign. J. Davis emphasized the need to speak with members about VOTE-COPE, the political action fund that helps us to support progressive candidates. The PSC needs allies in political office who share the union's concern for public higher education.

### Mass Meeting October 26th/Union week/Campus Action Teams

One thousand members have RSVP'd for the Mass Meeting on Winning a Just Contract on October 26, when the union will kick off the contract campaign. Following the mass meeting, the first week of December will be Union Week, when a series of local actions will be held. Chapter chairs are in discussion with their executive committees and Campus Action Teams (CATs) about engaging members around issues elevated by the Contract Priorities Survey responses. CATs convene centrally through monthly university-wide meetings of representatives from each CAT. The next central CAT meeting is tomorrow, Fri Oct 21, at 12 noon.

## **CUNY Board of Trustees Public Hearing**

PSC officers and members testified at CUNY's first in-person hearing since the pandemic on issues important to our contract and budget campaigns. A number of Hunter Brookdale Campus students and faculty also participated to express concerns about the announcement from the Governor and Mayor of the new health sciences hub.

#### Alternating meetings in person and remote for the rest of the academic year

Recommendation: that the DA convene in person in alternate months. Safety protocols: Proof of vaccination required for entry, mask required throughout the meeting, no food in the meeting hall. Reevaluate if COVID rates spike.

### Nominations to replace Vice President for Part Time personnel

The PSC follows the Election Rules approved by the DA. As announced, nominations will be taken from the floor of the meeting. All delegates or their alternates are eligible to vote. If there is more than one eligible candidate and all candidates consent, an election will be conducted electronically by secret ballot administered by PSC staff.

Eileen Moran nominated P. Stemberg Angel Martinez nominated Lynne Turner

Both candidates accepted the nomination and agreed that PSC staff would run the election at the DA meeting.

After a secret ballot administered electronically, the election results were tied. A runoff election via mail ballot will be conducted by AAA, pursuant to the PSC constitution.

#### III. Legislative Report - L. Elliott - Negri

**Federal Level:** The PSC is working on turning members out to vote in three congressional district races in NY - 3, 4 and 11. L. Elliott- Negri asked Delegates to sign up to get involved in general election work at the federal level. It is important for public higher education support to hold the Democratic majority in the House.

**State Level:** The PSC is working on completing our budget demands and preparing for engagement with the executive branch in Albany. L. Elliott-Negri urged Delegates to vote for Kathy Hochul on the

Working Families Party line. The Working Families Party line needs a minimum number of votes cast for their endorsed candidates to maintain ballot status.

City Level: City agencies, including CUNY, are facing a proposal from the Executive branch of the city to cut 3% in the middle of the fiscal year. CUNY management had to submit plans to the executive branch. The PSC opposes; it is not possible to move this without approval of the City Council.

**Medicare Advantage:** The Mayor, with the support of the MLC, is trying to change the administrative code on the health insurance floor for city workers, retirees, and dependents. PSC members and staff have been organizing and encouraging Council Members not to reduce CUNY's budget mid-year or change the health insurance floor for city workers. Every member of City Council is up for reelection in 2023.

Coalition report: AndreaVásquez announced that PSC has received a \$50,000 grant from AFT's Powerful Partnership Institute to organize PSC members to support the work of the CUNY Rising Alliance. Geoff Kurtz and Susan Kang are the project coordinators and are working to build out CUNY Rising Alliance (CRA) activity at the campus level. Their first charge is to identify CRA liaisons on campuses and increase the level of collaboration between PSC members, and student and community organizations. G. Kurtz and S. Kang have been working with Chapter Chairs to identify liaisons.

Financial Report - F. Wharton July and August Finances

# Financial Report - F. Wharton Monthly Financial Report - July

Total Operating Income \$1,736,000 Total Operating Expenses \$1,287,000 Surplus (Deficit) \$449,000

As of July 31, 2022, the financial statement shows an eleven-month surplus of \$58,000 when year-to-date expenditures are compared with year-to-date income. PSC spent \$18,647,000 and received \$18,705,000 over the eleven-month period.

#### **Monthly Financial Report - August**

Total Operating Income \$1,382,000 Total Operating Expenses \$1,527,000 Surplus (Deficit) \$ (145,000)

As of August 31, 2022, the financial statement shows a twelve-month deficit of \$87,000 when year-to-date expenditures are compared with year-to-date income. PSC spent \$20,174,000 and received \$20,087,000 over the twelve-month period.

MOTION: To accept the August 2022 Treasurer's Report (Motion: J. Batiz; seconded) APPROVED.

F. Wharton reported on the proposed budget for 2022-2023 and delegates discussed the proposed budget extensively.

MOTION: To double chapter budgets by taking from consultation line: (Motion: S. Chen-Hayes, seconded). FAILED.

MOTION: To approve the proposed budget 2022-2023 (Motion: H. Meltzer, seconded.) APPROVED.
