II. President's report and discussion (including written) - J. Davis

Bargaining Updates and Contract Campaign

President Davis discussed ongoing negotiations between the PSC and CUNY management regarding salary proposals and non-economic demands. The union has held mass meetings, online sessions, and borough-specific actions to mobilize support and pressure CUNY management. Plans for upcoming actions include a union-wide action on December 2nd, aiming for a just contract and conveying a message to the governor regarding the executive budget. A. Vásquez elaborated on this "Sing Out and Shout Out for A People's CUNY" rally. The union has a goal to bring 1500 PSC members, along with legislators, other unions, students, and coalition partners to demonstrate unity in budget and contract demands. The event aims to be creative, enjoyable, and visually impactful, featuring singing, performances, student voices, and theatrical elements.

President Davis addressed concerns raised in the DA listserv about the challenges and successes of the ongoing contract campaign. He emphasized the importance of member engagement and organizing

basics and highlighted the role of Campus Action Teams in expanding union reach. There is a need to reach out to non-members, particularly among full-time faculty, and to encourage active recruitment. He urged circulation on the campuses of the pledge card to serve as a tool for organizing conversations, allowing colleagues to commit to various levels of involvement. Any outstanding pledge cards should be submitted for analysis to inform assessments of capacity and member engagement.

Free speech at CUNY

President Davis addressed the recent conflict in Israel and Gaza and expressed condolences for the loss of life. He repeated the union's statement condemning the violence and emphasized the importance of communication, free speech, and mutual understanding. He expressed it is important for the union to send a clear message to the CUNY Chancellor about the value of freedom of speech and assembly, voicing concern that recent actions by the administration have made the campuses less safe for our students, faculty and staff.

These include statements from the Chancellor that took an imbalanced position with regard to protections of speech and general community safety for some rather than all members of the CUNY community; decisions by the Brooklyn administration that included to moving a student-organized demonstration for Palestinian rights at Brooklyn College off-campus due to public pressure, but having no response to the presence of counter protestors including an armed Republican member of the city council at the otherwise peaceful demonstration; and the Board of Trustees moving its October 16 public hearing online, in violation of the state open meetings law.

In response, he proposed that the union send a message to Chancellor Matos Rodríguez emphasizing the fundamental value of freedom of speech and assembly for all members of the university community. The union will draft a letter, and members will have the opportunity to sign in support. President Davis further suggested that the union can do more to support members when their political expression is targeted and weaponized in the media and proposed reaching out to the Faculty First Responders and the national affiliate AAUP to provide workshops and resources for members facing harassment.

Membership Report- A. Vásquez

Summer membership blitzes were especially successful in signing up many new members, and chapters where there's been concentrated focus have brought in new colleagues to the union. To build on these successes and to increase membership overall, First Vice President Vásquez emphasized targeted outreach and relationship-building with potential members.

With turnover challenges, especially among adjuncts, intentional relationship-building in the absence of traditional face-to-face interactions is even more important. Overall, there is a need for continued effort, data analysis, and intentional engagement to address challenges and boost membership for the long term. We will be regularly reporting on membership and giving time to it in future DA meetings.

Healthcare and Municipal Labor Committee

The PSC is looking into the possibility of submitting an amicus brief in the City's appeal against the decision in favor of the organization Public Service Retirees that prevents the City from implementing Medicare Advantage for its retirees. President Davis relayed that the City issued a request for information for alternatives to the current comprehensive benefits plan for active members, and is in the process of reviewing submissions from insurance companies to potentially replace Emblem/GHI. There has been very little reporting about any of the substance of the finalists, and there have been delays in the review process. The implementation date of January 1, 2024 has been moved to July 1, 2024. Two finalists have been identified: Aetna and Emblem/GHI in collaboration with United Health. While any plan would include premium free options with choices for providers and hospitals, it is highly likely that the plans will include price tiering of hospitals and outpatient providers.

- Union-wide elections 2024: The committee established a schedule for the 2024 union-wide elections. It is as follows:
 - o December 1st Deadline for an individual to become a member in good standing and be eligible to vote
 - o January 12 Deadline for submitting declaration of candidacy
 - o January 26th Pre-printed nominating petitions available
 - o March 1 Deadline for completed nominating petitions to be received by the Elections Committee
 - o April 1st Ballots mailed
 - o April 30th Deadline for ballots to be received
 - o May 1st Ballots counted
- Executive Council: Recognized the election of Larry Bosket as Vice President of Cross-Campus Units at the Delegate Assembly meeting on September 21.
- HEO Chapter: Recognized the resignation of Lauri Aguirre and Arthur Ben Chitty as delegates.
- York Chapter: Recognized the election of Matthew Garley and Gila Acker as alternate delegates and the resignation of Andrea Boffa as alternate delegate.
- BMCC Chapter: At BMCC's September 20 chapter meeting, there were 4 nominees for 2 alternate delegate vacancies. The elections committee established the schedule for the election, which is currently underway. Voting started on October 11 and will end November 11.
