II President's report and discussion - J. Davis

President Davis announced that Pete Zwiebach, Director of Legal Affairs, is leaving the PSC after 16 years.

Contract campaign and negotiations

We have new bargaining and bargaining orientation dates after three months. CUNY hired an outside consultant who used to bargain for the MTA to support their team. The bargaining team is committed to securing a favorable deal before summer. It has continued to meet regularly and work on demand development even when not at the bargaining table. The mismanagement of the bargaining process and CUNY itself on the part of the chancellor and the CUNY Board of Trustees is a focus of our spring campaign, which we will amplify with escalating actions, as well as student and public facing components. February 29 is a key date marking both a bargaining meeting and one year without a contract, and delegates should be looking for news about actions that day. We will hold workshops on civil disobedience and the Taylor Law beginning in March. Through the contract campaign we have opportunities to engage our members directly on issues that are of broad, deep interest. We're expecting counter proposals from CUNY regarding multi-year appointments for adjuncts and on our proposal for across-the-board salary increases—their economic offer will be an important inflection point in our campaign and should be a moment for wider agitation and outreach to members.

There are going to be other points of leverage this Spring, including BoT public hearings and the release of the State Assembly and State Senate budgets. We are hoping to have a couple of contract-specific actions in the month of March; one coordinated across different campuses and chapters where we're going to really need to hear from and work with the CATS and the chapter chairs and one in Albany. In April, we'd like to do a union-wide, centrally organized contract action before spring break.

Budget campaign, including current "colleges of concern"

President Davis highlighted widespread activism across campuses in response to midyear budget cuts. Actions are planned at York and Queens on the first day of the semester. Despite discouragement at every level, from college presidents to the Governor telling us that there's nothing that can be done about the budget, we must advocate for alternatives and the envisioning of a different university model. The executive budget that Hochul just announced is underwhelming, but it's also not unexpected. We're going to increase the executive and capital budget numbers again this year.

CUNY decided to target nine colleges and told them to submit savings plans, making additional cuts to the Fiscal Year 2024 budget, right before the holidays. One common feature among all the schools is that the spring schedules are being micromanaged. Enrollment limits for a class to run are rising. Enrollment caps are also being raised. Adjuncts and in some cases substitute lecturers are being laid off just weeks before classes start. On December 18th, these concerns were voiced to the Board of Trustees and the Chancellor. President Davis commended the affected chapters and Chapter Chairs for their proactive efforts over the break to try to get some level of transparency and accountability for what is going on at their campuses.

The university amended its state budget request, gutting \$180 million worth of programmatic needs, and they removed \$61 .5 million worth of restorations of the city's PEG (Program to Eliminate the Gap). President Davis argued there are four things CUNY should do: reverse the December cuts on these nine campuses, eliminate the central vacancy review board, spend down the \$105 million in COVID stimulus money, and submit a budget request that meets the needs of the university. The union's messaging around this fabricated crisis is that we don't have an enrollment problem, we have a retention crisis and an understaffing crisis facilitated by CUNY's mismanagement.

III Legislative report - H. James

The Mayor and the Governor announced their preliminary budgets on the same day. In the City budget, the Mayor is giving more agencies exemptions on budget cuts than he's done previously, including the NYPD, FDNY, CFNY. We're talking to CUNY administration and to our allies in the City Council to tell them that CUNY should also be exempt. The Mayor admitted that revenue growth was better than previously projected State preliminary budget includes a community college funding floor. The capital investments budget looks similar to last year.

VI Unfinished business, New business, and Announcements

Chapter reports: Medgar Evers and LaGuardia Community College

A. Medgar Evers - Kevin Adams

The college was fortunate to learn that they were not one of the schools that had to submit an enhanced savings plan. They are still dealing with leaks, rats, bed bugs, mold infestations, and a member of senior leadership chided a person for speaking to representation on campus. In response, the chapter sent a stern letter to the administration regarding bullying and the need to allow people to exercise their collectively bargained rights and not discourage them from doing so. At the State of the College, the President celebrated increased enrollment. Some senior administration have left the college: the senior vice president/chief of staff and legal counsel. They see this as a trend that administration is not in it for the long run.

B. LaGuardia Community College - Carrie Conners

One issue that has been an organizing point for the past year is our struggles with HR. They are making it exceedingly difficult to access contractual benefits such as medical leaves and accommodations. Recently, HR asserted that people cannot apply for sabbatical leave until after their 6th year of service. They were able to get them to concede on this point with help from Contract Enforcement. A petition calling for change in HR was delivered to the President and resulted in the opening of a search for a permanent HR Director.

VII Small Group Discussion GROUPS: Contract, budget and other issues

Delegates broke out into small groups. Cuts to "colleges of concern (Q and Y), Cuts to "colleges of concern" (BC, CSI, KCC, NYCT, JJ, BMCC, SPS), Brightspace, Professional Staff Workload Survey, Winning Job Security contract demands, CRA and CUNY in Coalition, PSC's State Budget Request and Spring campaign escalation.
