II. President's report and discussion - J. Davis

Negotiations and Contract Campaign

The May 20 rally at BCC was successful. We had 140 members show up despite CUNY changing the location at the last minute. The chair of the CUNY board of Trustees was flummoxed by our action.

CUNY has tried to use the Spring calendar to make us accept an inadequate proposal they say is "comprehensive" for 4.5 years, with 3%, 3%, 3.125%, 3.125%, with ratification bonus for FT workers, with other demands right before the state budget was about to close. They claimed it would be disastrous if we didn't get an agreement before then. We rejected that unfounded notion.

CUNY has started to move in our direction in other areas, moving on remote work, lecturer professional advancement, raises with promotions, adjunct multi-year appointment, and others. We are not going to rush to reach an agreement before the June 6 budget deadline without getting what we need. In the past, we received retro-pay that was covered and it should be again.

We told CUNY that their suggested changes to the Bylaws are inconsistent with the contract and they need to negotiate with the union over these changes. We will file PERB charges if they don't withdraw proposed changes or agree to bargain.

Membership - A. Vásquez

We have 192 new members since January 1st, equally divided between part- and full-timers. However, there is the churn of people leaving employment as well so we remain flat – same 88% fulltimers. We need to increase the rate at which we reach new hires to ask them to join the union if we are to raise membership numbers. I encourage you to continue your outreach to new hires about joining the union.

City Budget - J. Gaboury

The mayor has proposed 140 million dollars in cuts to the CUNY budget. We are going to need to work to get the City Council, even our supporters, to up the allocation to CUNY.

We will be in Coney Island on Tuesday, June 4 from 6:00-8:00pm. We want you to hold June 20 for a budget hearing at City Hall. We also have an action letter about our city budget ask on the website and postcards to the Mayor here in the office. There will be flyering in front of City Hall at the Council Stated meeting from 12-2pm on the next five Thursdays.

Settlement agreement - Online training grievance

We grieved and we won! This summer, CUNY will pay \$1.73 million to 4,311 members. The members covered by the grievance will receive \$900 minus any amount they may have been paid already.

The AFT encourage all locals to participate in local coalitions and efforts to advance implementation of the Inflation Reduction Act to transition their schools, universities and hospitals to clean energy alternatives; and

The AFT and its locals pressure the States to do more to enable every community to make the energy transition especially by making no-interest loans available for up-front costs for decarbonization for public schools, universities, and hospitals; and

The AFT and its locals prioritize low income communities that are, in general, more vulnerable to the predicted ravages of climate change and more likely to experience the high asthma rates associated with burning fossil fuels; and,

The AFT and its locals urge and support efforts to ensure our young people engage in robust, meaningful, interdisciplinary climate change and climate justice curricula with the goal of preparing students to participate productively and responsibly in a rapidly changing world, and in emerging green, sustainable professions; and

The AFT advance this work through articles in American Teacher and state-wide communications, paving the way for AFT locals to join coalitions and organize for cities, towns, counties and states to support and facilitate the efforts to implement the IRA in our public schools, universities and hospitals.
