II President's Report and Discussion - J. Davis

6:40-7:55

Negotiations and Contract Campaign

It's still difficult to get CUNY to confirm bargaining dates. Things are progressing at the table. CUNY had been spending time on items like trying to force an artificial deadline on us and not on actual negotiating. We've had 23 bargaining sessions so far. We hope to reach a strong agreement this summer. Thanks to the bargaining team members who are in here not only for bargaining sessions but for preparation. We are working on improved research awards, reassigned time, and other items. We have moved them on our demand for raises of at least one step with reclassification and promotion. There is movement on remote work, retro pay, and lecture advancement but the movement has not been enough and we need to keep pushing them.

July 9 is our next negotiations orientation if you want to join bargaining.

Friday June 28, 9am: We are going to 100 Wall Street to make our voices heard to the CUNY board chair Bill Thompson and ask for a better contract.

MOTION: To limit questions to two minutes. (Motion: C. Shacter-DeChabert; seconded) **APPROVED.**

CUNY Bylaws proposed changes

Beyond being terrible changes for the university, they must be negotiated with the PSC. That is another outstanding item that needs to be resolved before a contract can be achieved. We gave CUNY a deep presentation on June 3 but they seemed perplexed. The changes CUNY is proposing are not "formalizing existing practices" as they state but would modify the contract and they must negotiate with us. If they reject mandatory collecting bargaining, they are violating state law. We are preparing a grievance to file and an improper practice charge with PERB.

PSC reserve investments

There was a request from some delegates on 6/14 to share how PSC funds are invested. We have 10M in reserves, information is in the union's annual financial audit published in

Clarion. The reserve is invested by the finance committee. The finance committee follows a policy that has 85% in fixed income and 15% in equity, which are in index funds. \$2.25 million in Equities and \$8.05 million in fixed income.

F. Wharton -The investment manager uses the principles of the committee. They meet quarterly to review investments. Excess funds go into reserves. The objectives are that ROI should exceed the rate of inflation and the other is to have low risk and return - it is a conservative fund.

Membership - A. Vásquez

We have a 2024 summer membership drive where we will be going to each campus for membership outreach. We are asking each delegate to sign up for at least one day to help the organizer for your campus. We could bring in hundreds of new members. The visits start from the week of June 17 and go until August 26. The sign-up link is in This Week and the homepage. I will report back in the fall.

City Budget - J. Gaboury

CUNY is facing \$95 million in cuts and the budget is scheduled to be wrapped up next week. Please contact your council members and go to the webpage to send a letter to the mayor. The city council supports us and feels CUNY funding is a priority. But negotiations between the council and the Mayor are far apart. TPP and PSC have collected thousands of postcards urging the mayor and council to restore CUNY funding. Delegates living in council districts of Dinowitz, Brannan and Speaker Adams should call those offices encouraging them to restore \$94 million in funding for CUNY and \$35 million for ASAP and CUNY Reconnect. Members who live in those districts will be contacted.

Communications: Our new Communications Associate, **Daniel Kaplowitz** started June 3. He recently completed the Union Semester program at IATSE and has strong administrative, writing and digital media skills and has already had success supporting our comms work.

Administration: Our new Executive Assistant to the Principal Officers and Executive Staff, **Ambar Cordero** will start on July 8. She comes to us from Hotel Trades Council, where she

performed a wide variety of administrative functions, including overseeing training and member service programs.

Executive Director: The Executive Council has voted to appoint a new PSC Executive Director and we are happy to present the candidate to you tonight for Delegate Assembly approval. An extensive search was conducted with 25 applicants applying and the search committee was unanimous in recommending the candidate.
