II. President's report and discussion - J. Davis

2024 Elections and paths forward

First, I want to acknowledge the visceral experience of this political moment. We are experiencing this moment in different ways. We are differently vulnerable. I want to list some ways we can defend and stay on the offense. This is a moment for the left and our friends in the Democratic party to figure out how to organize.

The playbook for Trump consists of: 1. Distrust of institutions and fear of immigrants 2. Play to economic anxieties 3. Only a white man can handle this. Don't trust the DEI candidate.

Trump has announced his attack plan on higher education. Reclaim Higher Ed from the Radical Left. This can be found on YouTube. We will need to build coalitions to fight back against this. His plan includes:

Defund Pell Grants - CUNY receives \$1 billion annually in federal aid Tax college endowments

Target faculty members for what they teach, how they teach, what they say outside of the classroom,

Broadening Attack on Title IX

Target undocumented immigrants via mass deportations

There are some checks and balances against these changes, but Trump's plan is to dismantle them. What is PSC's plan? We've begun discussing ways to move immediately to develop plans together, figuring out how to protect our most vulnerable communities. Trump's attacks will be broader than those in his first term. We need to convene an emergency committee on immigrants' rights. Build coalitional relationships between organizations that are struggling similarly to protect people. It is very clear that they are targeting gender nonconforming people and trans and LGBT people. We need to create a place for people who are angry and want to fight back from within the union. We've discussed putting together a forum from social movement organizations and people within our ranks. We have enormous resources within the CUNY community.

The PSC Plan

Protect Vulnerable Communities PSC Emergency committee on Human Rights On rights of LGBTQ+ and gender nonconforming people Forum: Supporting Vulnerable Communities

Protecting Academic Freedom Forum: Academic Freedom, Constitutionally Protected speech, Title VI

Public Higher Education's Future Forum: Federal support, state and local support for public higher ed

Protect and Advance the rights of Organized Labor Forum: the NLRB, federal law, NYS (Taylor Law)

It's very clear what the Trump administration wants to do with public sector unions federally. In New York, we're governed by the Taylor Law. Private sector unions are especially vulnerable, but it's no walk in the park for the public sector.

We need a resurgent Left. For the Left to be resurgent in this moment, we cannot be beholden to a party, also can't play purity politics, need to build sustainable coalitions with each other. The left will win because it believes in collective action, antithesis of Trump's philosophy, society does not have to be a zero-sum game.

We are positioned well. We can lead. We are a 30,000 member union, not massive, but we are positioned to respond to this moment. We are a union of academic faculty, professionals, and students.

Contract negotiations and campaign

The pickets have been incredible. The effect has been very clear to management: we're not getting worn down, and we're not going away.

What's happening at the table is directly related. People have been showing up to bargaining sessions. CUNY can't turn around without seeing you. Where are things at in bargaining? There have been three phases: for the first year, CUNY was very unserious and unprepared;

They were not engaging. It took them until the last state budget cycle to present an economic package.

The next stage we were bargaining more, but CUNY was working off the DC37 CUNY agreement as the box for our negotiations. In the fall, they began to negotiate on our issues without coming off the "CUNY Pattern".

It wasn't until we pushed at John Jay and 30 were arrested that we pushed into the most recent, third phase. It has been more intense in terms of substantive engagement, and we moved them off of their opening economic position. The incremental changes moved closer to the UFT across the boards. Every quarter of a point is \$6M. They put forward a new economic proposal on October 24th, we countered on November 8th with a 5-year contract with 3.5% general wage increases (GWIs) and a number of equity targets. CUNY countered on November 15th with an offer of 4-years plus an extension, 3%, 3%, 3.25%, 3.5%. They have proposed cash bonuses in their offer, but the problem is most of the needs our members have can't be solved by cash. That's one time money that they're trying to use to meet structural needs we've identified. We're trying to figure out ways to deliver more value for all members plus additions towards equity needs.

There is real resistance on some of the most important items. The university has agreed to extend the remote work agreement, through the end of the contract. But that's not what we aimed for. They have also resisted on Appendix E, adjunct multi-year appointments; their proposal is still unacceptable. They want to tear up Appendix E and hate that we've won so many grievances.

They are also concerned about the governor releasing her executive budget in January and not having the collective bargaining costs included. CUNY doesn't want to go through that. They want to get that in before January. They want a tentative agreement, pending ratification, that they can send to the board of trustees. We feel our own urgency in this moment. We're not walking away from the table until we feel we've won a strong contract. Some of us have not experienced a raise since November 2022. It's way too long. They've seen already, we're not rolling over, and to the extent we want those raises in the state budget, but really it's their problem. That's why we are constantly in subcommittees with them, and we have bargaining sessions Monday and Tuesday. We're going to use that urgency to try to get what we need.

Contract and membership - A.Vásquez

It continues to be powerful to have members in the room during bargaining. The bargaining team decides when to bring the Memorandum of Agreement to the Executive Council for its approval and when that happens, the MOA goes to you, the delegates. You vote on whether

members will have the opportunity to ratify the contract. If the majority of the delegates approve, it goes to each dues paying member to vote.

We want to get the completed draft to members ahead of the vote, more than the two days is required in our Constitution. If it gets to members it means the DA has approved it.

This is also the optimal time to talk to non-members about membership. Non-members cannot vote on the contract. The raises they will receive are because of the contract and the thousands of members who have worked on this campaign. They, too, should join.

III. Legislative Report – J. Gaboury

With Governor Hochul, it's about extracting the most that we can at a particular moment that she controls. We will be demanding the state of New York do something outside the pattern and contract, and it's about the use of those things.

Last night's legislative committee meeting featured a HEO from the Grad Center who is a mapping expert. He will help provide a demographic analysis of how CUNY students and workers vote ahead of the 2025 Mayoral race.We've discussed our VOTE COPE money in the past two weeks. We made a decision to split the money between traditional contributions and an advocacy fund. Some of the work we've addressed tonight is something that the advocacy fund could finance. The legislative committee will come back soon with a timeline on city elections. Unlike other cycles where the PSC defers to AFT and NYSUT, we will be able to make our own endorsements. We will be active in the mayoral, city council, comptroller races.

A number of us were at the Public Power hearing last night at John Jay about building 15gW of public power in New York. We are still in a public comment period where people can submit comments, we will distribute information. Today there was a rally sponsored by 32BJ against hospital price gouging. We are a member of their coalition, part of what we want to do is pull in members who have experience with this issue. If you know members who have experienced hospital price gouging, we would love to hear their testimony. There's an opportunity to think outside the box about improvements to municipal health care with some of the candidates in the race.
