II. President's report and discussion - J. Davis

PSC and our Fights Forward

There is a revenue campaign in the state, Share Our Wealth, that has real traction. There is an opportunity to participate in a campaign that will generate \$3 billion for the state. There are th modest bills. One bill will increase the top personal income tax rate by 0.5%. Another bill will increase the corporate tax rate by 1.75%. All of NYS labor is behind this: https://shareourwealthny.org/.

The TAP gap was draining the budgets of our colleges for many years, but the gap was closed. Reform has expanded since then so that more students can take part in the tuition assistance program. Having legislation that would extend TAP funding for undergraduate students to six would help a lot of students. There is another bill to expand TAP funding for graduate students

On the national level, we have hard right politicians that are pushing to cut funding for vital programs: healthcare, food assistance, shut down services, lay off workers, and try to get

personal data for hundreds of millions of Americans. Now is our time to stand together and secuts to working people to fund tax breaks for billionaires.

AFT and AFL are litigating to stall the implementation. But we need to be on the streets, not ju the courts. NIH and NSF: share stories of impacts to these programs – there is a form on the F website to create a bank of stories. "Dear Colleague" letter to President of Harvard impacting programs.

RF Field Units contract campaign - (A. James)

Has been in bargaining for several months, since last August. The update is on the PSC websi does have about 500 workers including City Tech, LGCC, and SLU, GC. All of us are paid througrant funding form public and private sources. The RF keeps rejecting our most pressing demands, including around wages and appointment renewals. We had a petition signed by 14 workers, many of whom showed up to bargaining. We are in the midst of planning our next acand ask for support to take us to the finishing line.

Membership - (A. Vásquez)

This is a key moment for union membership: after the new contract is ratified.

January 2025: 139 new members, 55% FT

February 2025: 76 new members so far.
