1 Resolution in Defense of Academic Freedom & Against Retaliatory Firing of CUNY Faculty

- 3 Whereas, academic freedom is a cornerstone of higher education, protected by university policy,
- 4 the PSC contract, and widely accepted principles laid out by the AAUP, and is essential to the
- 5 mission of colleges and universities as spaces of open inquiry, critical thought, and democratic
- 6 engagement;
- 7 Whereas, Brooklyn College recently terminated one adjunct faculty member and non-
- 8 reappointed at least three others almost simultaneously in what appears to be retaliation for their
- 9 lawful political expression outside of the classroom;
- Whereas, CUNY administration has refused to explain the basis for these non-reappointments to
- 11 the faculty members and their chairs, leaving speculation as the only response;
- Whereas, each of these faculty members was approved for reappointment by their respective
- 13 Appointments Committees and Chairs consistent with CUNY bylaws and Brooklyn College
- practices; they were placed on the Fall teaching schedule; and each has an exemplary record as
- 15 instructors of CUNY students;
- Whereas, breaking with practices for hiring, staffing, and scheduling at Brooklyn College, these
- 17 non-reappointments and termination set a dangerous precedent that chills free speech,
- undermines faculty governance, and signals to faculty and students alike that political expression
- and activity outside the classroom is punishable;
- 20 **Be it resolved** that the PSC unequivocally condemns the retaliatory dismissal of these faculty
- 21 members and demands their immediate reappointment;
- 22 Be it further resolved that the PSC will assist these and other similarly situated faculty
- 23 members in obtaining from the CUNY administration a full and transparent explanation of the
- 24 reasons for their termination or non-reappointment;
- 25 **Be it further resolved** that the PSC calls on the CUNY administration to reaffirm its
- 26 commitment to academic freedom and to freedom of expression for all faculty, staff, and
- 27 students, regardless of employment status;¹
- 28 **Be it further resolved** that the PSC will pursue all available avenues—including legal,
- 29 contractual, organizing, and public advocacy—to defend the rights of its members.

Our colleges and universities share a commitment to serve as centers of open inquiry where, in their pursuit of truth, faculty, students, and staff are free to exchange ideas and opinions across a full range of viewpoints without fear of retribution, censorship, or deportation."
