I. Approvals

A. Agenda

MOTION: To approve the agenda (Motion: J. Batiz; seconded) APPROVED.

B. Minutes - June

II. President's Report and discussion - J. Davis

A. Federal fight forward; September 25 demonstration

President Davis discussed PSC's ongoing federal fight-back efforts, and the need to defend research, academic freedom, immigrant communities, international students, faculty and staff, the teaching of honest history and analysis, disciplinary expertise, faculty governance, and First Amendment rights both on and off campus. The importance of not only defending these rights but also advancing proactive initiatives to protect them was emphasized.

The PSC has remained active in immigrant solidarity work, with many members participating in court watch activities over the summer, accounting for 360 individual courtroom visits. The PSC is the one labor union maintaining a consistent presence in immigration courts, and its efforts have helped lead CUNY to establish a rapid response portal for students, faculty, and staff facing immigration-related challenges. The union continues to collaborate through the Central Labor Council to involve additional unions in this work.

Other active working groups include those focused on defending research funding, sexuality and gender, academic freedom, the social safety net, and environmental justice. Defense of academic freedom remains a major priority, particularly around the campaign for the four adjuncts non-reappointed from Brooklyn College. That fight continues through grievance and arbitration processes and a strong public campaign led by the Brooklyn chapter and allies across CUNY.

The Social Safety Net Working Group is tracking federal threats to programs such as Medicaid and SNAP that could undermine state and city budgets. The Environmental Justice Committee continues to lead climate-related advocacy and their resolution calling for renewable energy development on CUNY, SUNY, and public sites will go before the NYSUT Board this weekend, with PSC delegates and allies from UUP and UFT pushing for its approval. Treasurer Wharton also launched two new initiatives: the PSC BIPOC Group, meeting in October, and the Teacher Education Working Group, which will hold an all-day conference that same month.

Nationally, AFT and AAUP are pursuing litigation to defend academic freedom, including recent victories against Trump-era measures targeting Harvard and UC Berkeley.

Today, PSC members, including Secretary Andrea Vásquez, participated in a major civil disobedience action at 26 Federal Plaza opposing ICE operations and mass deportations, as part of the broader push to pass New York for All legislation.

Upcoming coalition actions include a large demonstration against ICE on September 25, the No Kings demonstration on October 28, and a town hall meeting with the New York Metro Coalition for Higher Education on October 29, leading up to a citywide march on November 7.

B. Proposed contract NYC health insurance

Information was presented regarding the proposed replacement for the GHI comprehensive benefits plan for New York City employees. The Municipal Labor Committee (MLC) has scheduled a vote for September 30 for member unions to consider approval of the new plan, New York City Employee PPO, which would be administered jointly by Emblem and United Healthcare beginning in January 2026.

The proposed plan would maintain provider continuity, automatically enroll current GHI members, and retain all existing in-network hospitals and doctors, while expanding coverage through the United Healthcare National Network outside the 13 downstate counties. Additional provisions include adding New York City Health and Hospitals to the zero-copay tier, maintaining current out-of-pocket costs, and expanding access to mental and behavioral health providers. The city would self-insure the plan, thereby assuming responsibility for claim payments and administrative costs, as well as control over future plan changes.

However, there are concerns about the lack of transparency, as the contract contains significant redactions that prevent full understanding of how the plan will save the city the advertised billion dollars per year, particularly beyond 2026. The healthcare working group recommended that the PSC abstain from the September 30th vote due to concerningly inadequate information and an unacceptable process.

Resolution:

Having reviewed the publicly available materials about the proposed NYC Employee PPO Plan and heard from PSC's representatives who viewed the redacted contract and attended the MLC briefing, the union's Health Care Working Group finds the available information concerningly inadequate, finds the process unacceptable, and recommends that the PSC abstain the September 30 MLC vote on approving the Plan. MOTION: Approve the Healthcare Working Group's recommendation (Motion: PSC Health Care Working Group) **APPROVED.**

C. Proposed Research Foundation Field Units Contract - A. James

Antonica James, chapter chair from the Research Foundation field units, presented a memorandum of agreement covering nearly 500 RF employees at CUNY Graduate Center, LaGuardia Community College, City Tech, and for the first time, CUNY School of Labor and Urban Studies. The bargaining team included Antonica James, Erica Guzman, Migdalia Ramos, and Donna Thompson-Ray, with support from PSC staff Brian Graf and Mitchell Manning and Jessica Leiken, from NYSUT, serving as lead negotiator. Their campaign included letters to management, social media efforts, a march on the boss, and a phone campaign by the delegate assembly.

After a year of difficult bargaining, the team secured several gains including: raises of 13.4% over four years with higher catch-up pay for those making less than \$20/hour, retroactive pay back to October 2024, signing bonuses between \$500-\$2,000 depending on status and service, expansion of tuition reimbursement benefits to part-time B employees, addition of a dignity and respect clause addressing workplace violence and bullying, better notification of reappointments, and access to new hire orientations.

MOTION: To recommend the Research Foundation Field Unit's Contract for Ratification by members. (Motion: A. James) **APPROVED.**

D. Proposed PSC Chapter CUNY Law School

A proposal was presented to establish a new chapter for CUNY School of Law, which has been part of the Queens College chapter despite being physically located in Long Island City since 2012. According to the PSC constitution, the delegate assembly has the authority to establish new chapters, and each unit of CUNY can constitute a chapter. The Law School has approximately 69 full-time faculty and several dozen adjunct faculty who are ready to step into union leadership positions. A representative from the law school, Kara Wallis, explained that the energy for forming the chapter came from recent attacks on academic freedom, including at a congressional hearing where a representative asked to terminate the employment of a colleague. The Law School is also in an interim dean period, and faculty want to strengthen coworker solidarity during this transition.

MOTION: To authorize the establishment of a PSC chapter at the CUNY School of Law (Motion: Executive Council; seconded) APPROVED.

III. Administrative Items

A. Legislative Report (J. Gaboury)

Members of the Legislative Committee previously met with Melanie D'Arrigo from the Campaign for the New York Health Act to discuss strategies for expanding union support for universal healthcare. A joint session with the Social Safety Net Committee is being considered to continue this discussion and build on prior engagement with Senator Gustavo Rivera.

The PSC is working to elect Zohran Mamdani as Mayor of New York City. The campaign is looking for public policy experts from CUNY to speak on various issues. The PSC has created a roster of member experts to share with the campaign, helping to highlight the expertise of CUNY faculty and staff in public discourse.

The PSC continues to organize around tax justice and revenue generation, advocating that the ultra-wealthy pay their fair share to protect public services and jobs amid federal cost-shifting. The union is coordinating with NYSUT and the Central Labor Council in this effort and holding weekly phone banks on Wednesdays from 6–8 p.m. with participation from the Working Families Party and allied groups. Members can also volunteer through the District Captain Program where you can connect with people in your own election district.

The union is also focusing on voter registration, particularly among CUNY students, with the Environmental Justice Working Group conducting climate town halls that include voter registration components. The PSC is partnering with NYPIRG chapters and CUNY Votes to register voters electronically and on paper ballots until the October 25th deadline.

The PSC is also involved in several key City Council races, including support for Ben Chou, a Baruch graduate and firefighter running against incumbent Vickie Paladino. The Executive Council recently voted to endorse Chu's campaign. Additional information and participation links will be shared with members through the Delegate Assembly listserv.
